



## **MILL CREEK POOL RULES**

1. Hours of operation for the pool will be from 8:00 A.M. until sunset. Individuals using the pool after hours or when the pool is closed will be subject to a fine.
2. Due to health concerns, no smoking is allowed in the pool area. All smoking must take place outside the gated area. Receptacles will be provided. Smoking in the pool area or in the pool or lazy river is subject to a \$100.00 fine and the owner's amenity card may be deactivated.
3. Non swimmers must be accompanied by a capable swimmer.  
Any person with incontinence problems must use an appropriate swim diaper. There will be a \$100 Fine for non-compliance and the owner's amenity card may be deactivated. In addition if the pool requires treatment for contamination (human feces), fines up to \$1000.00 will be levied to cover the treatment. (Regular diapers will not be allowed and residents will be asked to leave the pool water.
4. Guests should be limited to no more than five (5) people per household at any one time and must have proper supervision.
5. Do not use the pool when under the influence of alcohol.
6. No glass is permitted anywhere in the pool area. Violation of this rule is subject to a \$100.00 fine and the owner's amenity card may be deactivated.
7. Proper swimwear is required. No jeans, cutoffs or thongs.
8. No solo swimming.
9. Each person using a float, supplied by Mill Creek, should use 1 float at a time. Any person seen destroying a float will be fined \$260.00 for each float damaged or destroyed. Amenity card may also be de-activated.
10. Everyone must take a shower before entering the pool.

11. Running, pushing, causing undue disturbance, or any conduct that may endanger the welfare of self or other members is prohibited. This type of activity may result in the member being asked to leave the pool area for the day.
12. Diving is not permitted into any part of the pool area.
13. Bikes, skateboards, motorized children vehicles and roller blades are prohibited within the fenced amenity area.
14. During severe weather conditions (heavy rain, lightning, thunder and warnings) individuals must get out of the pool and seek shelter.
15. No pets are allowed in the pool or pool areas.
16. Food or drinks are not permitted in the pool or lazy river. Violation of this guideline is subject to a \$50.00 fine. Food and drinks are permitted in the deck area.
17. Dispose of all trash into trash receptacles.
18. Use of personal audio equipment must be used with head phones in the pool area. Violation of this rule is subject to a \$50.00 fine.
19. Foul or abusive language will not be tolerated and the member may be asked to leave the amenity for the remainder of the day.
20. A person(s) may be asked to leave the pool area if there is any condition or evidence which in the opinion of the security firm or Superior Management Services, LLC will jeopardize the health and safety of them or other guests.
21. Children's strollers must remain at least eight (8) feet from the pool.
22. Inflatable rafts should not be larger than four (4) feet in length. Boogie boards and surf boards are not permitted. The HOA provided rafts should be returned to the racks after use.
23. All members use this facility at their own risk.
24. The HOA is not responsible for any valuables or personal property brought into the facility.
25. A security key is required for each family or individual while at the pool or the amenity center.
26. Do not move tables. Umbrellas should be closed after using.
27. Sidewalk chalk should not be used in the pool area.
28. Do not hold the gate open for people. Individuals who claim their card doesn't work maybe due to delinquent dues or they may not live in the community.
29. There are security cameras around the pool area for the safety of the residents. If you see someone breaking a rule, or who does not live in Mill Creek, call security or the Bluffton Police.
30. Any person failing to follow the rules is subject to fines and the revoking of all pool privileges. Any member behind on their HOA dues will also have their pool privileges revoked.

31. Closest phone for emergency use, along with the first aid kit, is located outside the pool equipment building by the bathrooms. Call 911 in case of any emergency.

32. Fireplace Rules:

- May River Pool Pavilion parties with paid and Superior Management Services, LLC confirmed amenity reservation will have exclusive access to the fireplace during their rental times. All other times will be under a first come first serve basis.
- Fire must be constructed and constantly supervised by an adult.
- Any mess or ashes from the use of the fireplace must be properly cleaned immediately after the party.
- Hot ashes must be disposed of in the properly specified metal container located next to the fireplace.
- Any member that uses the fireplace assumes all liability and is responsible for any damages.  
**\*Any member that does not adequately clean up after the use of fireplace may be subject to a \$100 fine\***
